We are concerned that Pétanque as an Olympic event will not be a success with the general public because it is difficult to follow and evolves too slowly. Three issues we highlight are ;-

1. Lack of action. Very little time is spent throwing boules. The spectator mainly sees players walking up and down.

- 2. Visibility of the Jack due to colour and size, for a spectator in the stands.
- 3. Assignment of boules to each team.

Many other sports have adjusted their rules or come up with new formats to increase their appeal to the general spectator and we call upon the FIPJP to set a Technical Group (TG) to examine the aspect of Pétanque as Spectacle and to make proposals for a dynamic game full of spectator interest.

Athletics Changed false starts allowed to 0.

Cricket. Introduction of limited over such as 20 20,

Rugby – only the short form sevens is an Olympic sport.

Bowls and Curling for colour assignment of team shirts, bowl and stone colour.

Tennis. Introduction of the tie break to restrict set length.
